Introduction

Some 2010 - 2011 model year Prius vehicles may exhibit one or more of the following conditions at initial engine start after cold soak in temperatures below $40^{\circ}F$ ($4.5^{\circ}C$):

- MIL "ON" with Diagnostic Trouble Codes (DTCs) P0300, P0301, P0302, P0303. and/or P0304.
- · Initially runs rough.
- Loud engine knock or rattle noise.

APPLICABLE WARRANTY

- This repair is covered under the Toyota Powertrain Warranty. This warranty is in effect for 60 months or 60,000 miles, whichever occurs first, from the vehicle's in-service date.
- For California specification Prius vehicles sold, registered, and operated in California, Connecticut, Maine, Maryland ('11 MY), Massachusetts, New Jersey, New Mexico, New York, Oregon, Rhode Island, and Vermont, the Intake Manifold is covered under the California Emission Warranty. This warranty is in effect for 180 months or 150,000 miles, whichever occurs first, from the vehicle's in-service date.
- For California specification Prius vehicles sold, registered, and operated in Pennsylvania and Washington, the Intake Manifold is covered under the California Emission Control Warranty which is in effect for 84 months or 70,000 miles, whichever occurs first, from the vehicle's in-service date.
- Warranty application is limited to occurrence of the specified condition described in this bulletin.

Repair Procedure

- 1. Use Techstream to check for DTCs, and confirm the condition per the Introduction.
- 2. Remove and replace the intake manifold with the updated part.

 Refer to the Technical Information System (TIS), applicable model year Prius Repair Manual:
 - 2010 Prius: Engine/Hybrid System – Intake/Exhaust – "2ZR-FXE Intake/Exhaust: Intake Manifold: Removal / Installation"
 - 2011 Prius: Engine/Hybrid System – Intake/Exhaust – "2ZR-FXE Intake/Exhaust: Intake Manifold: Removal / Installation"
- 3. Clear the DTC(s) and verify normal vehicle operation.
